3 (a) The objects to be pursued by the company on its incorporation are:

1 To promote quality education, especially in Information Technology and technical fields.
2 To promote or establish and manage institutions for academic, technical, and vocational training.
3 To promote enhance employability through skill development and practical training programs.
4 To promote conduct workshops, seminars, and career development programs for youth.
5 To promote digital literacy and IT awareness among students and underprivileged groups.
6 To promote collaborate with educational bodies and industries for training and placement help.
7 To promote develop and distribute educational content, e-learning tools, and resources.
8 To promote help for innovation, research, and entrepreneurship in the education and tech sectors.
9 To Promote or provide scholarships, mentorship, and help programs for deserving and weaker students.
10 To Promote entrepreneurship and startup culture through training,

incubation, and networking help.
11 To Promote or organize awareness campaigns on career opportunities, digital safety, and emerging technologies.
12 To Promote or undertake CSR projects, government schemes, or NGO collaborations in the education and skill sectors.
13 To Promote conduct assessments, certifications, and recognition programs for trained individuals.

(b) *Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1. To Promotion of education, learning, and skills development amongst individuals and provision of information, advice, and guidance, including career guidance, to people of all ages.
2. To run, manage, promote, and participate in all types of government and nongovernment programs for the development of society.
3. To employ any person, firm, or company for the purpose of carrying out all or any of the contracts from time to time entered by the Company upon such terms and conditions as may be thought expedient.
4. To enter into collaboration with any foreign firms for the purpose of carrying on any social activity that this Company is authorized to carry on.
5. To purchase or otherwise acquire and undertake all or any part of the property and transactions and liabilities of any person, firm, or corporation carrying on any social work that this Company is authorized to carry on or possessed of property suitable for the purposes of this Company.
6. To pay all or any costs, charges, and expenses preliminary and incidental to the promotion, formation,

establishment, and registration of the Company and the issue of its capital, and any modification of its Memorandum or Articles of Association and all applications to courts on behalf of the Company, along with all legal charges incurred or to be incurred by the Company.

7. To purchase, take on lease, or otherwise acquire any movable or immovable property and rights or privileges which the Company may think necessary or expedient for its social activities.

8. To insure the property, goods, commodities, articles, and assets of the Company to protect and indemnify the Company against liability or loss.

9. To carry on any social work or activity through any subsidiary company and to enter into arrangements with such subsidiary companies.

10. To appoint Directors or managers of any subsidiary company or of any other company in which this Company has an interest, subject to the Companies Act, 2013.

11. To promote any company to carry out any function or object of this Company.

12. To enter into any arrangement with any government or authority (Indian or foreign), municipal, local body, or corporation to obtain rights, concessions, and privileges conducive to the Company's objectives.

13. To appoint agents, subagents, representatives, and attorneys to carry out the objectives of the Company.

14. To institute, conduct, defend, or settle legal proceedings concerning the Company's affairs and to compound or allow time for payment or satisfaction of debts

or claims.
15. To procure the Company to be registered or recognized in any part of the world. 16. To carry out all other activities authorized by the Company in accordance with its objectives.
17. To act as a consultant, counselor, or facilitator in matters concerning food and livelihood security, local selfgovernance, strategic communication, and issues related to development or alternative paradigms.
18. To provide vocational or educational guidance and counseling by establishing, or conducting vocational guidance bureaus, either virtual or real.
19. To accept donations on behalf of implementing agencies from the government, foreign donors, and/or any other donor agency subject to applicable laws.

the doing of all such other lawful things as considered necessary for the furtherance of the above objects:

Provided that the company shall not support with its funds, or endeavor to impose on, or procure to be observed by its members or others, any regulation or restriction which, as an object of the company, would make it a trade union.

5 (i) The profits, if any, or other income and property of the company, when-so-ever derived, shall be applied, solely for the promotion of its objects as set forth in this memorandum.

(ii) No portion of the profits, other income or property aforesaid shall be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise by way of profit, to persons who, at any time are, or have been, members of the company or to any one or more of them or to any persons claiming through any one or more of them.

(iii) No remuneration or other benefit in money or money's worth shall be given by the company to any of its members, whether officers or members of the company or not, except payment of out-of-pocket expenses, reasonable and proper interest on money lent, or reasonable and proper rent on premises let to the company.

(iv) Nothing in this clause shall prevent the payment by the company in good faith of prudent remuneration to any of its officers or servants (not being members) or to any other person (not being member), in return for any services actually rendered to the company.

(v) Nothing in these clauses (iii) and (iv) shall prevent the payment by the company in good faith of prudent remuneration to any of its members in return for any services (not being services of a kind which are required to be rendered by a member), actually rendered to the company

6 No alteration shall be made to this memorandum of association or to the articles of association of the company which are for the time being in force, unless the alteration has been previously submitted to and approved by the Registrar.

9 True accounts shall be kept of all sums of money received and expended by the company and the matters in respect of which such receipts and expenditure take place, and of the property, credits and liabilities of the company; and, subject to any reasonable restrictions as to the time and manner of inspecting the same that may be imposed in accordance with the regulations of the company for the time being in force, the accounts shall be open to the inspection of the members. Once at least in every year, the accounts of the company shall be examined, and the correctness of the balance-sheet and the income and expenditure account ascertained by one or more properly qualified auditor or auditors

10 If upon a winding up or dissolution of the company, there remains, after the satisfaction of all the debts and liabilities, any property whatsoever, the same shall not be distributed amongst the members of the company but shall be given or transferred to such other company having objects similar to the objects of this company, subject to such conditions as the Tribunal may impose, or may be sold and proceeds thereof credited to the Rehabilitation and Insolvency Fund formed under Section 269 of the Act.

11 The Company can be amalgamated only with another company registered under section 8 of the Act and having similar objects.
